The last few decades have seen an explosion of technological solutions to many educational problems: online courseware for learners, virtual forms of teacher training, and a host of new Web tools that promise to improve access and efficiency in education. This workshop will introduce state staff to a number of the most promising innovations and describe the costs (hardware, software, maintenance, and training) associated with adopting them. Presenters will highlight strategies to assess the needs of local programs and provide the professional development that teachers and administrators must have to integrate technology into instruction. Presenters will describe key elements of a state technology plan and help participants draft “next steps” to guide planning.

This session will help state personnel answer questions from program directors or teachers, such as the reasons why programs must use a certain test, test students at specified intervals, and use specific test forms and levels when pre- and post-testing students. Participants will learn basic principles of good assessment, how to identify types of assessments, and how to use them (such as placement tests, formative assessments, achievement tests, authentic assessments). They also will learn about factors affecting test administration, scoring and interpretation of scores, and more.
